With the completion of this work, 4th line will be available for running trains for a distance of 4.8 kilometers between Tikiapara and Santragachi which will increase the flexibility in train operations in this extremely busy section. President of the Parishad, Sridhar Pessnia alleged that despite an MoU between VAL and Odisha government for provision of Bauxite mine through Odisha Mining Corporation (OMC) to run this plant, not a grain of ore was made available to the plant, causing apprehension about closure of the refinery.

The company is managing to get Bauxite ore from outside the state and country but it is highly expensive. The stage one environment clearance was accorded for mining in Niyamgiri, but stage 2 environment clearance was refused. Pessnia demanded that Bauxite be made available from any source to the plant for the running of the plant and to revive the economy of the area.
