With the Supreme Court verdict clearing the way for temple construction in Ayodhya, the holy city is witnessing a 'brickfall' of sorts.

VHP spokesperson Sharad Sharma said that the number of devotees coming to the workshop at Karsevakpuram has gone up dramatically after November 9 when the verdict was announced.

"In normal times, we had about 1,000 visitors every day. They were those who came to Ayodhya temples and dropped in to see the workshop. Now we have people who are coming specially to see the workshop. They offer prayers to the carved stones and many of them are bringing bricks as their contribution to the temple," he said.

There are many among the 5,000-odd visitors to Karsevakpuram who offer money for temple construction and are given a receipt
